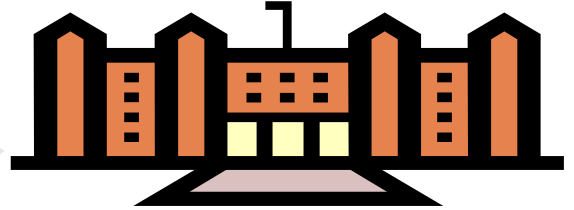

Tenders for Snow Removal Contract

The Chippewas of Nawash Unceded First Nation Board of Education are seeking tenders for a Snow Removal Contract to commence **November 2019 – April 2022** for the Kikendaasogamig Elementary School premises located at **45 Farm Road, Neyaashiinigiing, Ontario N0H 2T0**.

Brief Description of Contractor Duties:

1. Removal of snow and ice to be completed weekdays prior to 7:00 a.m. to ensure safe pedestrian and vehicular travel for entrance gateway into the school, school bus and visitor parking zone, staff parking zone, and other paved surface areas including asphalt playground area, as requested by the Principal.
2. Snow will be removed after any storm, whenever a blockage exists, or accumulations exceed six (6) inches.
3. Spread a light mixture of sand and salt/enviro salt to slippery areas to ensure safety and good winter parking conditions and pedestrian traffic, at all times.
4. Ensure that built up snow banks do not obstruct vision of oncoming traffic, access to outdoor air handling unit, garbage bin and mail box. Removal of accumulated banked snow is to be transported to an off-site location upon request of the Principal.
5. Contractor must provide their own equipment, fuel, salt/enviro salt and sand. Contractor will be held responsible for replacing and or repairing damage done to property while fulfilling these duties. Proof of a comprehensive general liability insurance policy is required upon submission.

All interested contractors are encouraged to request a detailed **tender requirements** package from the Board office, as well as, to inspect the grounds prior to submitting their bid.

All written bids with required documentation are to be submitted to the **Chippewas of Nawash Unceded First Nation Board of Education Office** in a sealed envelope that is clearly marked: **“TENDER FOR SNOW REMOVAL CONTRACT– KIKENDAASOGAMIG PREMISES”**. Submissions will be time and date stamped at the front desk.

Bids must be submitted by: 4:00 p.m. on Tuesday, September 3, 2019.
LOWEST OR ANY BID NOT NECESSARILY ACCEPTED. LATE BIDS WILL NOT BE CONSIDERED.
