There was some discussion about looking into having laptops/tablets to be provided at presentations so that surveys could be filled out online right away during a presentation. Carolyn stated that some laptops/tablets may be coming soon and we may be able to utilize these to provide some support to seniors and other groups in submitting surveys online. There was discussion around setting up more sessions. It was suggested that Nuala ask to attend the supervisors meeting and speak with supervisors on October 28th about setting up lunch-and-learn presentations for their own staff groups.

4. FLYERS AND COMMUNICATIONS TO MEMBERS

There was some discussion about the surveys online and Nuala noted that responses to the surveys completed using the link on the website are received by Michael Johnston. There was some concern expressed about privacy of the information and the timing of receiving reports on the surveys from Michael. Nuala offered to contact Michael every Monday and report to the committee, but it was decided that Nuala will obtain an MRP survey monkey license and work with Michael to set up links to our surveys so that we can review the results at any time. Nuala will reach out to Michael about setting up links on the website to our own Survey Monkey.
