The Chippewas of Nawash Unceded First Nation Board of Education is seeking sealed tenders for a Snow and Ice Removal Contract for the period: **November 2022 – April 2025**. Services to be performed at the following locations in Neyaashiinigiing:

- 1. Board of Education Administration Office**  
6 Harbour Road
- 2. Kikendaasogamig Elementary School**  
45 Farm Road
- 3. Nshiime Child and Family Centre**  
255 Prairie Road

### **DUTIES:**

- Snow & ice will be removed after any storm, whenever a blockage exists, or accumulations exceed six (6) inches or fifteen (15) centimeters.
- A light mixture of sand and salt/enviro salt will be applied to slippery areas to ensure safety and good winter parking conditions and pedestrian traffic, at all times.
- The contractor will ensure that snow banks accumulated throughout the season do not obstruct vision of oncoming traffic, access to outdoor air handling unit and garbage bins. Accumulated banked snow is to be removed and transported to an off-site location, upon request of the building/program Supervisor.
- The contractor must provide their own equipment, fuel, salt/enviro salt and sand. Contractor will be held responsible for replacing and/or repairing any assets damaged while fulfilling these duties. Proof of comprehensive general liability insurance policy is required upon submission of bid.

Interested contractors may request a detailed **Tender Requirements Package**, based on any/all locations above, from the Board office. Location grounds may be inspected prior to submitting a bid.

All written bids with required documentation are to be submitted to the Chippewas of Nawash Unceded First Nation Board of Education Office in an envelope marked: **TENDER FOR SNOW REMOVAL**. Please indicate location name & number on the envelope. Submissions will be time and date stamped at the front desk.

**Bids must be submitted by: 4:00 pm on Friday, September 9, 2022.**
