The Manager will be operating under the guidance of the North America Farmer Advisor Strategy Manager and will be connected to both the North America Agriculture program and the Nature United Natural Climate Solutions (NCS) team. Success in the position will be achieved by building foundational relationships with ag retailers, CPGs, commodity groups, farmer-led groups, universities, and NGOs in service of our shared programmatic goals. They will align with existing strategies, existing corporate and government engagement, and science and research teams. They will bring their knowledge, curiosity, and relationships to develop an agricultural strategy for the Great Lakes region of southern OntarioIn collaboration with and under the guidance of the North America Farmer Advisor Strategy Manager and other team members, the Manager will be responsible for:

- Acting independently within broad program goals to prioritize tasks in the absence of specific instructions and exercise independent judgment to identify and solve problems;
- Manage projects with multiple variables and internal and external stakeholders set realistic deadlines, manage a timeline and budget, and ensure accountability;
- Adapting TNC's and NU's agriculture strategies and theories of change (TOC) to local cultures and geographies;
- Identifying and developing key performance indicators and mechanisms for monitoring & measuring progress towards outcomes;
- Serving as the liaison for external partners and TNC staff to gain cooperation to accomplish program goals;
- Writing proposals and grants for public and private funding programs;
- Meeting planning and facilitation;
- Managing contracts, tracking budgets and deliverables, producing reports;
- Adhering to TNC standard operating procedures, approval and reporting requirements.

The Manager will be expected to travel up to 20% of their time and may work in variable weather conditions, at remote locations, on difficult and hazardous terrain and under physically demanding circumstances.
