Nawash Fire Department – MNRF – Forest Fire Management Agreement 6.5)

The Ontario Ministry of Natural Resources and Forestry has reached out to our local Fire Chief to explore the Chippewas of Nawash's interest in signing a First Nation Forest Fire Management Agreement. The agreement is similar in nature to the Mutual Aid Agreements Nawash has with South Bruce Peninsula and North Bruce Peninsula, but specific to Forest Fires. The agreement will ensure that Nawash has access to MNRF resources, including aviation support in the event of a Forest or Wildland fires. It also enables the Nawash Fire Department to invoice costs related to wildfires back to the MNRF. The MNRF will also provide training opportunities and resources to Nawash Fire Fighters.

The agreement allows the community to be able to invoice out any wildland fire suppression (ie. Grassfires). It also gives the community a direct link to the MNRF should we require their assistance in a more immediate situation. This agreement would assist the community as well as the hunting grounds. The MNRF will provide materials for training on wildland fires, including



training on the aviation portion. With the conditions of the community as well as the entire peninsula it is important that we take wildfires seriously.

Housing – H4H Agreement 5b):

Chippewas of Nawash Unceded First Nation has an agreement with NWMO called "This Second Amended Near-Term Investments Funding Agreement" which was signed on August 23, 2024, by Chief Greg Nadjiwon. The agreement has outlined Habitat for Humanity as the contractor to be hired to complete the two (2) 4-bedroom home builds. One at Lot 41-12 Farm Road and the other at Lot 9 Kaikaiknong Subdivision. Upon review of the NTI Agreement it was discovered that a BCR was not passed to sign the accepted NTI Agreement.

During the September 23, 2024, Council Meeting there was a discussion on the matter of these two builds as the funding for them is from a proponent. This led to a request for a meeting between Habitat for Humanity and CNUFN. That meeting took place on October 10, 2024. At that meeting it was determined that Habitat for Humanity's partnerships to construct Band Rental Assets does not align with their mandate. Given this information, it is recommended that Council pass a motion to accept an amended NTI Agreement to remove Habitat for Humanity (specifically) as the chosen contractor and broaden the definition to "an appropriate contractor selected by CNUFN Housing Department".

The contract between CNUFN and Habitat for Humanity is required to be retroactively approved by Council in order to release funds to Habitat for Humanity to complete the build as the build has already begun. The Housing Department recommends that Council pass a motion to accept the contract with Habitat for Humanity to build the 4-bedroom home at Lot 41-12 Farm Road for a flat rate of \$321,180.00 to be paid in four (4) installments.

Lands 5d): Over the years the Lands Department has visited the firehall road subdivision for survey bar locate requests.

More than normal, this subdivision usually yields high amounts of unsuccessful locate attempts. The band holds Lot 28-6-3 Concession 2 East. Landholder of Lot 28-6-2 Concession 2 East has requested the lands department to locate the survey bars along the line between band lot 28-6-3 and their lot 28-6-2 as they would like to build an addition to their home. In January 2025, attempts to locate the required bars were unsuccessful.

We are now requesting that the southerly line of Lot 28-6-3 be surveyed so as to find the line to prevent encroachment. Estimate provided being \$ 2,500.00 to ascertain the line (without setting new bars) or \$4,500.00 for setting new bars on entire lot. We think that the \$2,500.00 would suffice for this particular purpose.

**TCE Update 9):**

Norma - TCE pushing project hard due to time constraints that have been dictated by Ontario. Project will take three years to develop an engineering plan, to do all the research. In three years a decision needs to be made by all Players.

Paul - 285 Million dollars to do Class C estimation, at the end of 3 years they are to come back with the plans, costed out. Impact hasn't started yet because the project hasn't started, then this will take 3 years.

Norma - TCE is wanting SON to sign an Interim Agreement, which is different from the other Agreements we have signed in the past, this will tie us legally to the Project. Need to find out what this exactly means with PST, who will be at the meeting on Tuesday. They want the Agreement signed by July 2025 because of our Election in August, they feel the Election will slow the process down. We have to negotiate this Interim Agreement before the July date, Negotiation Team – two TCE people and one member from Nawash and one from Saugeen. Informed that we need at least two Councillors from each Community. Can bring back for discussion after meeting with Lawyers on Tuesday.

Paul – if we have an Agreement with TC Energy then we can talk about funding. If it was just an individual thing and the government wasn't involved then it would never go ahead. We need it to start our talks with Ontario in order to get a concrete business plan to be partners.

Norma – need a date to come back to Council to discuss and to appoint two people to this work. Meetings will be held two hours per week. Meeting will be held on February 11, 2025.
